## ILLINOIS STATE COMPTROLLER

### COURT OF CLAIMS AWARD LIMITS

Section 8(d) of the Court of Claims Act (705 ILCS 505/8(d)) increased the base limit on damages awarded by the Court of Claims for tort claims against the State to \$2,000,000.00 and requires the Illinois Office of Comptroller to determine each year the award limits for claims against the State for damages in cases of sounding in tort brought under the Act in accordance with the consumer price index-u (CPI-U) during the preceding 12-month calendar year.

#### 2023 Court of Claims Award Limits

According to the U.S. Bureau of Labor Statistics, the CPI-U increased by 6.45% during the preceding calendar year. Based upon the previous determinations, the liability limits are adjusted as follows:

- The limit for all awards in cases sounding in tort (other than in certain cases involving the operation of a State vehicle) filed pursuant to 705 ILCS 505/8(d) is \$2,407,899.43.

#### 2022 Court of Claims Award Limits

According to the U.S. Bureau of Labor Statistics, the CPI-U increased by 7.04% during the preceding calendar year. Based upon the previous determinations, the liability limits are adjusted as follows:

- The limit for all awards in cases sounding in tort (other than in certain cases involving the operation of a State vehicle) filed pursuant to 705 ILCS 505/8(d) is \$2,262,000.40.

#### 2021 Court of Claims Award Limits

According to the U.S. Bureau of Labor Statistics, the CPI-U increased by 1.36% during the preceding calendar year. Based upon the previous determinations, the liability limits are adjusted as follows:

- The limit for all awards in cases sounding in tort (other than in certain cases involving the operation of a State vehicle) filed pursuant to 705 ILCS 505/8(d) is \$2,132,618.41.

### 2020 Court of Claims Award Limits

According to the U.S. Bureau of Labor Statistics, the CPI-U increased by 2.29% during the preceding calendar year. Based upon the previous determinations, the liability limits are adjusted as follows:

- The limit for all awards in cases sounding in tort (other than in certain cases involving the operation of a State vehicle) filed pursuant to 705 ILCS 505/8(d) is \$2,084,874.78.

### 2019 Court of Claims Award Limits

According to the U.S. Bureau of Labor Statistics, the CPI-U increased by 1.91% during the preceding calendar year. Based upon the previous determinations, the liability limits are adjusted as follows:

- The limit for all awards in cases sounding in tort (other than in certain cases involving the operation of a State vehicle) filed pursuant to 705 ILCS 505/8(d) is \$2,038,200.00.
